## **10 Mooring Officer Update**

### **10.1 Moorings**

- On a Friday every other month or so Pat Jensen (PJ) will explain how moorings are laid, members' responsibilities, kit required, costs etc.
- RT suggested a short video could be recorded and could be sent via email.

### **10.2 Jetty**

- RT informed the Committee that the jetty is falling into disrepair, and should be condemned.
- We could use good wood from the old jetty and repair fishermen's jetty and use that one instead. Fishermen would also help maintain it.
- NB: there is no mention of a jetty in any official documentation (insurance, The Crown etc.)

### **10.3 Jet skis**

- RT contacted the Seafront Office because Sue from the Uphill Boat Services was complaining about the danger moorings lines were representing for jet skiers and could we contact the Water Safety Committee? RT got in touch with the Seafront Office and they have agreed in principle to put a notice on the pontoon “jet skis not allowed further up the river” as well as a notice on the jetty where they launch.

### **10.4 Gerald's boat**

### **10.5 Lifeboat**

- Is it insured? There has been a notice on the abandoned lifeboat for 6 months. If someone does pay their mooring fee, they agree to the club T&Cs (this includes that their boat is insured minimum 3<sup>rd</sup> party).

### **10.6 Pontoon**

- Move the “dangerous” up river section. Keep the centre section is strong enough.
- Original anchor chains are going to be repositioned if necessary.
- There would be a section which can be used for 24 hours as one wishes, and other section with consent.
- Martin Page is making metal work.
- Pylons for leaning posts have been purchased.
